

## CONDITIONS OF LICENCE UNDER THE GAMBLING REGULATORY AUTHORITY ACT 2007

The conditions imposed by the Gambling Regulatory Board (GRB) under section 97 of the Gambling Regulatory Authority Act 2007.

## Bookmakers operating at the racecourse, inside the Stand

1. You should conduct your betting operations in accordance with the approved rules for Bookmakers operating at the racecourse issued to you and all the provisions of the Gambling Regulatory Authority Act 2007 relevant to your licence.

2. Your licence is issued for operation as bookmaker at the Champ de Mars for Location/s **AXX** and **SXX** 

3. You should on each race meeting day, at least one-hour before the scheduled time of the start of the first race as printed in the official programme, vacate and close your Location **AXX** and proceed to operate at Location **SXX** 

4. (i) The Upper Limit of the sum total of the odds, for a *'book'* of Rs 500, should be as follows :

Race with up to 6 horses:Rs 650Race with more than 6 horses :Rs 750

- (ii) The Lower Limit of the sum total of the odds, for a *'book'* of Rs 500, should be Rs 575, except for coupled bet.
- 5. The operating hours are as follows:-
  - (a) Race day falling on a Saturday
    - (i) Thursday: As from the time (12.30 hrs) of the issue of the official programme of racing events to 16.00 hours on that day.
    - (ii) Fridays and Saturdays: From 09.00 hrs to 17.30 hrs.
  - (b) Race day falling on a Sunday
    - (i) Friday: As from the time (1230 hrs) of the issue of the official programme of racing events to 16.00 hours on that day.
    - (ii) Saturdays and Sundays: From 09.00 hrs to 17.30 hrs.



6. Your business premises shall remain open on the first working day from 12.00 hrs to 15.30 hrs following the day the race meeting has been held for effecting payment of any outstanding winning/refund bets. You should make necessary arrangement to enable payments to be effected continuously during the opening hours.

7. Access shall be prohibited to minors on your licensed premises when betting transactions are carried out.

8. You should, at all times, display in a conspicuous place on your premises a notice board each of size of at least 21 cm x 30 cm with letters of size of at least 1 cm wide specifying:-

- a) The hours of operation.
- b) Hours of payment
- c) Note for prohibition of betting by minors

9. The betting software used to record betting should be configured to comply with the Conditions of Licence and approved Rules.

10. You should keep, in hard copy, the original betting ticket of the winnings or refunds paid for a period of at least five years after the completion of the transaction to which it relates.

11. Any record kept in relation to your business should be produced to the Authority upon request.

12. No claim shall be entertained in respect of a lost or mutilated ticket.

13. Unclaimed funds which comprises of unclaimed winnings, unclaimed refunds, or any amount unpaid in respect of lost or stolen or mutilated tickets, shall be paid into the National Solidarity Fund within 7 days after the expiry of 30 days from the date of the race meeting.

14. Every bookmaker shall, at all times when his premises are open for betting activities, display in a conspicuous place at the premises, a notice informing public that the time limit to claim any winnings or refund, is within 30 days from the date such winning or refund becomes payable.

15. You should immediately after payment of any unclaimed prize or other amounts to the National Solidarity Fund submit to the Gambling Regulatory Authority a certified statement showing the particulars of the amount paid. Nil return should also be submitted.

16. You should at the time of submission of any return/ statement related to Betting Tax – Bookmaker to the Mauritius Revenue Authority forward a copy to the Gambling Regulatory Authority (GRA).

17. Each Registration Certificate issued for Bookmaker's Clerk is valid for a period of three (3) years as specified thereon. All valid Registration Certificates issued prior to 01 July 2016 shall expire on 30 June 2019.



18. Every Bookmaker's Clerk shall, at all times whilst on duty in the course of his employment conspicuously wear his valid registration certificate issued by the Gambling Regulatory Authority.

- 19. The Gambling Regulatory Authority reserves the right to:-
  - (a) direct the relocation of your premises to such area as it may determine; and
  - (b) limit the number of renewals of licence.

20. It is understood that the grant of a licence does not exempt you from compliance with any other law or from obtaining authorisations, licences or permits from other relevant authorities.

Non-compliance with any conditions of licence, rules, regulations or other provisions of the Gambling Regulatory Authority Act may entail any action deemed appropriate.

These Conditions may, at any time, be varied, amended or otherwise altered during the currency of the licence in accordance with section 97 of the Gambling Regulatory Authority Act.
