## CONDITIONS FOR DART GAMES OPERATORS

## Conditions of Licence under the Gambling Regulatory Authority Act 2007

The conditions imposed by the Gambling Regulatory Authority Board under section 97 of the Gambling Regulatory Authority Act 2007 for the racing season 2017.

- 1. You should keep only your approved Dart Board/s for which licence has been paid for the racing season 20XX in your stand no. **XX** at Champ de Mars.
- 2. Dart Board/s for replacement of worn existing one/s should be submitted to Gambling Regulatory Authority for approval at least forty eight hours before.
- 3. You should not allow minors to participate in dart games.
- 4. A notice prohibiting minors from participating in dart games should be conspicuously placed at your stand. The notice board should be of size of at least A4 with letters of size of at least 1 cm wide.
- 5. You should display in a conspicuous place at your stand your Licence, Conditions of the licence and Rules for operating Dart Games.
- 6. The Gambling Regulatory Authority reserves the rights to :
  - (a) direct the relocation of your premises to such area at it may determine; and
  - (b) limit the number of renewals in future in conformity with any applicable law.
- 7. Upon application for the renewal of your licence, any licence fee specified in the Third Schedule shall:-
  - (i) For the period 1 January to 15 August be paid not later than 15 days before the day of the first race meeting.
  - (ii) In any other case, be paid before the expiry of the period of the licence specified in that schedule.



8. (i) Should you fail to pay the licence fee specified in 7 (i) above within the time limit prescribed, you shall be liable to pay in addition to the licence fee payable, a penalty of 50 percent of the amount of the licence fee payable, provided that payment is effected before the day of the first race meeting.

For 7 (ii) above, provided that payment is effected before the expiry of the period of the licence specified in that schedule.

- (ii) Where the licence fee and the penalty are not paid within the time limit, you shall cease to carry on business upon expiry of your current licence and shall comply with the requirements of the Gambling Regulatory Authority Act relating to a person who has ceased to carry on business.
- 9. You should comply with item 13 of the third schedule of the Gambling Regulatory Authority Act relating to the authorised day and time for operation of Dart Games. Extracts of which are reproduced hereunder:-

Authorised days and time Days immediately preceding race day falling on Saturday -Day Time Thursday 13.00 hrs to 18.00 hrs

Thursday	13.00 hrs to 18.00 hrs
Friday	10.00 hrs to 18.00 hrs

Days immediately preceding race day falling on Sunday -

Time
10.00 hrs to 18.00 hrs
10.00 hrs to 18.00 hrs
09.00 hrs to 18.00 hrs

Monday immediately following race day -12.00 hrs to 16.00 hrs

10. It is understood that the grant of a licence does not exempt you from compliance with any other law or from obtaining authorisations, licences or permits from other relevant authorities.

Any failure on your part to comply with any condition of this licence, any rule for operating dart games or any provision of the Gambling Regulatory Authority Act 2007 may entail any action that the Authority may deem fit.



For avoidance of doubt, these conditions may, at any time, be varied, amended or otherwise altered during the currency of the licence in accordance with section 97 of the Gambling Regulatory Authority Act.
