GENERAL

Trainer Hewitson appeared before the Stipendiary Stewards together with Jockey Ramsamy to confirm a change of tactic for BRAVE BOMBER in race 2.

The following trainers and jockeys appeared before the Stipendiary Stewards to confirm their instructions and discuss their intentions in their respective races:

- Race 3: FURIE NOCTURNE (Trainer Allet and Jockey Schwarz)
 QUATRO FIVE SIX (Trainer Mahadia and Jockey Perez)
- Race 4: SUPER EXCITED (Trainer Mahadia and Jockey Perez) CHOSEN WAY (Trainer Mahadia and Jockey Oodith) GRAND VISION (Trainer Allet and Jockey Schwarz)
- Race 7: GLOBAL GLORY (Trainer Mahadia and Jockey Perez)
 CARTEL BOSS (Trainer Mahadia and Jockey Joorawon)



RACE 1: THE BET 593 RESPONSIBLE GAMBLING CUP 1365M – [BM 36]

The start was delayed after ROYAL SOVEREIGN broke through the front gate of the starting stalls and dislodged Jockey Curatolo, bolting the course. Upon recommendation of the Regulatory Veterinarian, the Stipendiary Stewards ordered its withdrawal. In view of the behaviour of ROYAL SOVEREIGN in the starting stalls, the Stipendiary Stewards have suspended the horse and advised Trainer Mootien that ROYAL SOVEREIGN will be required to pass a barrier trial to their satisfaction prior to being eligible to race again. All monies invested on ROYAL SOVEREIGN were ordered to be refunded. A deduction of 20 cents per rupee was declared.

CHARLIE SQUADRON was fractious in the starting stalls, jumped awkwardly and was slow to begin.

MASTER POINT leant against the right side of its starting stall as the gate opened and was slow to begin. Passing the 1300m, after being urged forward, commenced to race fiercely and had to be steadied when awkwardly placed close to the heels of FENCING CAPTAIN.

FENCING CAPTAIN came off the 1300m crossing awkwardly.

MASTER POINT raced fiercely in the early and middle stages. When questioned, Jockey Schwarz explained that he had been boxed in during the early stages with MASTER POINT overracing in the middle stages and when asked for an effort passing the 400m, MASTER POINT failed to quicken and faded in the home straight. He further explained that MASTER POINT made a breathing noise in the pull up.

Leaving the 100m, FENCING CAPTAIN commenced to shift ground outwards resulting in Jockey Mansour shifting his whip to his left hand.

RACE 2: THE BET 593 HEAD-TO-HEAD CUP 1500M - [BM 41]

HIGH KEY was slow to begin.

FIREFLARE hesitated on jumping and was slow to begin and was urged forward and from leaving the 1365m commenced to race fiercely.

Passing the 1200m, FIREFLARE became cramped on the inside of BRAVE BOMBER which had shifted ground inwards for a number of strides.

HIGH KEY had to be steadied passing the 1200m when awkwardly placed close to the heels of KAROO LARK.



Approaching the 1000m, OPAGUE was urged forward to secure the lead, when unable to do so, did not insist and stayed in a one-off position.

BRAVE BOMBER raced wide throughout.

Approaching 600m, HIGH KEY was switched to the outside of KAROO LARK to improve its position.

Passing the 450m, FIREFLARE came off the crossing awkwardly and shifted ground outwards resulting in HIGH KEY improving on its inside.

HIGH KEY hung in, in the home straight.

RACE 3: THE BET 593 BETTING WITHOUT FAVOURITE CUP 1365M – [BM 46]

ALPINE CHALLENGE rushed the front gate of the starting stalls prior to the start being effected.

IDITAROD TRAIL jumped awkwardly and was slow to begin.

FURIE NOCTURNE half reared on jumping and was slow to begin.

Leaving the 1000m, QUATRO FIVE SIX was urged forward to race next to the leader.

Passing the 600m, Jockey Joorawon felt something amiss with LICKERIO and eased this gelding out of the race at the 400m.

Passing the 600m, BALOUCHI was taken out to avoid the heels of LICKERIO which was giving ground quickly.

Passing the 450m, IDITAROD TRAIL and FURIE NOCTURNE were switched outwards to avoid the heels of LICKERIO.

CANFORD LIGHTS leaving the 200m, was switched to the inside to secure clear running.

Trainer Mahadia and Jockey Perez appeared before the Board and preliminary evidence was taken at an inquiry into the running and riding of QUATRO FIVE SIX. On continuation of the inquiry, Jockey Perez was found guilty of a contravention of Rule 43.2.1, in that after securing a one-off position behind the leader, when the pace was a regular one, instead of settling his mount to give it a breather between the 1000m to the 700m, he allowed his mount to stride forward wanting to secure the lead and thereby failing to take all reasonable and permissible measures to ensure that QUATRO FIVE SIX was given the full opportunity to obtain the best



possible placing in the race. He was suspended from riding in 4 Mauritian race meetings and fined 50 000 MUR.

RACE 4: THE BET 593 MONEY BACK CUP 1500M - [BM 56]

CHOSEN WAY after jumping with the field, refused to gallop and turned sideways dislodging Jockey Oodith. CHOSEN WAY was quickly reined in and led off the course by the handlers. In view of the performance of CHOSEN WAY, the Stipendiary Stewards have suspended this gelding indefinitely.

SUPER EXCITED was slow to begin.

SECRET OASIS, passing the 1300m, had to be eased when awkwardly placed close to the heels of CAPTAIN COLA.

SUPERIOR FORCE raced fiercely in the early and middle stages and when being settled, threw its head and raced ungenerously for some distance.

Leaving the 450m, JOIN THE DOTS was switched to the outside of GRAND VISION to secure clear running and raced wide into the home straight.

Leaving the 100m, JOIN THE DOTS was hanging inwards and brushed GRAND VISION carrying the latter inwards, with GRAND VISION having to be switched in, to avoid the heels of CAPTAIN COLA which shifted ground outwards abruptly in the concluding stages, slightly inconveniencing JOIN THE DOTS.

RACE 5: THE BET 593 DEAD HEAT CUP 1500M - [BM 56]

ABSOLUTIST slow into stride.

WILLIE JOHN jumped awkwardly and was slow to begin.

SPIRIT'S UNITE raced wide in the early stages. An inquiry was held into the handling of ZOOMIE and evidence was taken from Jockey Manuel Nunes and Trainer Ramapathee Gujadhur. Jockey Nunes explained that he opted to stay in a one-off position close to SPIRIT'S UNITE, which he considered to be his main danger in the race. On questioning as to whether there was an option for him to take an inside run approaching the 400m, he stated that he had already made the decision to opt for an outside run since he could not risk having VAN HUNKS not leaving the rails. It was at the very moment he executed his chosen option, that VAN HUNKS left the rails thereby creating a gap, albeit too late, for him to take. Trainer Ramapathee Gujadhur stated that in hindsight this was the better option at the time Jockey M. Nunes had to make his decision. After hearing the evidence, the Stewards decided not to proceed further with this inquiry, having been satisfied that the explanations of Jockey Nunes were plausible on a reading of the film of the race.

Approaching 600m, ABSOLUTIST was urged forward, failed to respond and gave ground to the field. Jockey Rama signed and Admission of Guilt for a contravention of Rule 29.2.3 in that whilst riding the horse ABSOLUTIST, he used his whip in an improper manner when this horse had no reasonable prospect of improving its position. He was fined MUR 2,000.

Leaving the 600m, WILLIE JOHN was switched to the outside of ZOOMIE to improve his position. ZOOMIE was taken out to improve its position resulting in WILLIE JOHN being eased and taken back inwards.

Approaching the 450m, ZOOMIE raced wide.

ZOOMIE and SPIRIT'S UNITE made the turn into the home straight very wide.

RACE 6: THE BET 593 – MTC BICENTENARY TROPHY G2 1500M – [BM 60+]

Upon arriving at the start, Jockey Nunes expressed concern regarding the soundness of ITSRAININGWILLIAM. It was examined by the Regulatory Veterinarian and found to be lame near fore. Upon recommendation of the Regulatory Veterinarian, the Stipendiary Stewards ordered its withdrawal. In view of this, the Stipendiary Stewards have suspended the horse for seven days and advised Trainer Gujadhur that ITSRAININGWILLIAM will be



required to pass a barrier trial, to their satisfaction, prior to being eligible to race again. All monies invested on ITSRAININGWILLIAM were ordered to be refunded. A deduction of 20 cents per rupee was declared.

On inquiry, Trainer Gujadhur explained that ITSRAININGWILLIAM had been fitted with leather wedges on both fore hooves, on advice of the farrier during the preceding week and this may have contributed to the deterioration of the gelding's fitness leading up to the race. The Stipendiary Stewards drew Trainer Gujadhurs' attention to the rules of racing where specially fitted shoes should be declared and that the Stipendiary Stewards should be notified in terms of Rule 38.2.1.

MERIDIUS and GOOD COUNCIL were slow to begin.

Approaching the 1300m, WOLF MOUNTAIN was restrained resulting in YOUR PACE OR MINE, which was following, commencing to race fiercely and when restrained to avoid the heels of WOLF MOUNTAIN, YOUR PACE OR MINE got its head up and raced ungenerously for some distance with Jockey Rama becoming momentarily unbalanced and falling back in his saddle near the 1100m.

Near the 1200m, MERIDIUS was restrained when awkwardly placed close to the heels of YOUR PACE OR MINE and when being restrained shifted ground outwards, GOOD COUNCIL which was following, was inconvenienced and carried wide, was then restrained and taken back in to secure a position closer to the rails.

From leaving the 1100m, when the pace slowed, MERIDIUS commenced to overrace and was taken out from behind THE GATEKEEPER and allowed to stride forward to secure the lead.

GOOD COUNCIL from approaching the 450m, was switched to the outside of runners to improve its position and raced very wide rounding the home turn.

WILLIAM IRON ARM, leaving the 250m, commenced to shift ground inwards and carried MERIDIUS, which was improving on its inside, inwards.

In the concluding stages, WILLIAM IRON ARM, which was hanging in shifted ground inwards resulting in MERIDIUS having to be taken out to continue going forward.

After the running of the race, Trainer A. Nagadoo requested permission to view the footage of the home straight and lodged an objection against the winner, WILLIAM IRON ARM, on the grounds of interference in the home straight and being crossed in the closing stages. After hearing evidence from Trainers V.Allet, A.Nagadoo, Jockeys Schwarz and Sooful, the Board overruled the objection, where the judges semaphore numbers were declared.

RACE 7: THE BITVILLE X BET 593 CUP 1365M – [BM 66]

BETATHANTHEREST had its head turned sideways when the start was effected, jumped awkwardly and was slow into stride.

ROYAL WULFF was slow into stride.

CARTEL BOSS jumped awkwardly and shifted ground inwards bumping COLOUR MY FATE.

GLOBAL GLORY raced wide in the early stages.

Leaving the 450m, BETATHANTHEREST was switched to the outside of CARTEL BOSS to improve its position.

COLOUR MY FATE commenced to give ground passing the 450m and was not persevered with in the home straight.

GLOBAL GLORY leaving the 300m was shifted to the outside of runners to improve its position and raced wide into the home straight.

ROYAL WULFF passing the 250m, was switched to the inside of CARTEL BOSS to secure clear running.

RACE 8: THE MANGALKHAN PLATE 1500M - [BM 31]

CUMBRE VIEJA half reared on jumping.

CITADEL was slow into stride.

KALGOORLIE raced wide in the early stages.

CAPTAIN'S CONSORT raced wide in the early stages and from 1200m, was allowed to stride forward to secure a position closer to the rails.

ARNICA MONTANA passing the 450m, was taken out to improve its position and raced wide into the home straight.



CUMBRE VIEJA from passing the 300m, had difficultly in negotiation the turn into the home straight and raced wide rounding the home turn.

KALGOORLIE leaving the 200m, was switched to the inside of VIKING TRAIL to continue going forward.

When questioned with regards to the poor performance of KAISARISSA, Jockey Joorawon stated that from the 800m that the gelding had a tendency to falter and from the 400m, when asked for an effort, it failed to quicken. He added that from leaving the 200m that the gelding felt very awkward, and decided not to persevere with it over the concluding stages.
