GENERAL

1. At an inquiry concluded on the 3rd October 2025, into the matter of Jockey Santana riding at trackwork on the 10th September 2025, the Stipendiary Stewards, after having carefully assessed the evidence of owner Chui Wan Cheong and reviewing CCTV footage of his whereabouts and interaction with various relevant persons on the 10th September 2025, including Trainer V. Ruhee, the Stewards decided not to charge Mr Chui Wan Cheong with a breach of the Rules of Racing on this occasion. Mr Chui Wan Cheong was reminded that, as an owner, who is on the premises of the horse racing organiser, he must at all times comply with any reasonable order given to him by a licensed official.
2. Trainer Subaraj Gujadhur signed an Admission of Guilt for a contravention of Rule 11.2 of the Racing Calendar in that he failed to declare a Tongue Tie on the horse WILLIE JOHN on the designated form by latest noon, on the day prior to declarations. He was fined MUR 15,000.
3. Trainer Ramapatee Gujadhur signed an Admission of Guilt for a contravention of Rule 11.2 of the Racing Calendar in that he failed to declare Alumite shoes on the horses:
 - Race 4: MONUMENTAL
 - Race 7: AT MY COMMAND

- Race 7: PORT LOUIS
- Race 8: JOIN THE DOTS

on the designated form by latest noon on the day prior to declarations. He was fined MUR 15,000.

RACE 1: THE BOBCAT CHALLENGE CUP 1365M – [BM 41]

Acting upon the Regulatory Veterinarians' advice, received on Saturday, 4th October 2025, SAN ANDREAS was withdrawn at 9:05 a.m. effectively. All monies invested on SAN ANDREAS were ordered to be refunded. A deduction of 10 cents per rupee was declared. The horse has been suspended for fourteen days (off feed).

HAVANA MOON jumped awkwardly.

TSUNAMI WARNING jumped awkwardly, threw its head and shifted ground outwards, was then taken back inwards towards the rails to race behind runners.

Passing the 400m, TSUNAMI WARNING shifted out from behind COLOUR OF MONEY to improve its position and raced wide in the home straight.

RACE 2: THE SACHIN SOHODEB MEMORIAL CHALLENGE CUP 1450M – [0-25]

Whilst being loaded, CATCHA DRAGON became fractious and threw its head down with the handler attending to it as the start was effected, resulting in the handler still having a hold of CATCHA DRAGON's rein with CATCHA DRAGON losing ground and being slow out. On

inquiry, after the review of the footage from different angles and hearing evidence from Jockey Danielson, the Stipendiary Stewards being of the opinion that CATCHA DRAGON was denied a fair start, acting under the provision of rule 42.16 declared the gelding a non-runner. The Stipendiary Stewards, not being satisfied with the performance of CATCHA DRAGON in the starting stalls, suspended the gelding for seven days and advised Trainer A. Nagadoo that this gelding will have to pass a barrier trial to their satisfaction prior to being eligible to race again.

MALINOIS was slow into stride.

CLOUD SEEDER raced wide throughout.

Passing the 1200m, RIVER HAWK stumbled for no apparent reason and thereafter raced fiercely in the middle stages with Apprentice Sophie having some difficulty in restraining his mount.

Approaching the 600m, RIVER HAWK which was over-racing, was switched out to avoid the heels of CELESTIAL MAGMA.

RIVER HAWK and CELESTIAL MAGMA raced wide on the final turn.

Passing the 200m, CATCHA DRAGON shifted out away from the whip with Jockey Danielson changing his whip to his left hand.

RACE 3: THE SOIL PLUS COMPOST CHALLENGE CUP 1600M – [BM 36]

LORD OF LIGHT jumped awkwardly outwards, throwing its head, shifted ground outwards losing considerable ground, was then taken back inwards sharply towards the rails to race behind runners.

HIGH KEY was slow to begin.

ALL ABOUT LOVE was slow into stride.

Approaching the 1400m, MASTER POINT shifted ground inwards and had to be restrained when awkwardly placed close to the heels of GONNABEALRIGHT.

Leaving the 1300m, CUMBRE VIEJA had difficulty in negotiating the turn, shifted out slightly carrying GONNABEALRIGHT wider on the track.

LORD OF LIGHT raced wide passing the 1300m and was taken back inwards.

Approaching the 600m, LORD OF LIGHT when improving on the outside of PIETER BOTH, was carried out wide when PIETER BOTH was taken out to improve around ALL ABOUT LOVE.

In the early stages of the home straight HIGH KEY was switched to outside of MASTER POINT to secure clear running and from passing the 100m was hanging in and proved difficult to be assisted.

LORD OF LIGHT was hanging out in the home straight.

RACE 4: THE SP ECOGROW PLUS CHALLENGE CUP 1365M – [BM 51]

ONE AND ALL was slow to begin.

MONUMENTAL was fractious in the starting stalls and was slow to begin.

Passing the 1300m, NATIONAL AWARD had to be checked when momentarily cramped for room on the inside of HARDFALLINGRAIN which had shifted inwards. On inquiry, it was established that approaching the 1300m, HARDFALLINGRAIN commenced to shift ground inwards despite Apprentice Taka's attempt to straighten it, resulting in NATIONAL AWARD shying away from that gelding and shifting ground inward and when being taken back out, threw its head. Under these circumstances the Stipendiary Stewards decided not to proceed further with this inquiry.

MONUMENTAL raced wide in the early stages and approaching the 1200m, was switched inwards to secure a position on the rail behind runners.

From leaving the 1100m, MONUMENTAL commenced to race fiercely and approaching the 1000m, had to be restrained when awkwardly placed close to the heels of FURIE NOCTURNE.

Leaving the 800m, MONUMENTAL had to be restrained when awkwardly placed close to the heels of EMERALD BAND.

Passing the 900m, FURIE NOCTURNE was switched to the outside of EMERALD BAND to improve its position and in doing so carried ONE AND ALL wider on the track.

Leaving the 700m, ONE AND ALL was eased and taken inwards to secure a position one off the rail behind FURIE NOCTURNE.

NATIONAL AWARD hanging in from the 900m.

Passing the 400m, the saddle of NATIONAL AWARD slipped sideways with Jockey Joorawon becoming unbalanced and having difficulty to properly assist his mount in his home straight. In this incident, Jockey Joorawon accidentally dropped his whip at the 350m.

NATIONAL AWARD hanging in badly, proving difficult to be properly assisted in the home straight.

Leaving the 200m, MONUMENTAL was switched to the inside of FURIE NOCTURNE to continue going forward.

RACE 5: THE SP ENRICHED TOPSOIL CHALLENGE CUP 1600M – [BM 56]

Prior to the race, whilst being saddled, WILLIE JOHN spread its near hind shoe which was attended to and refitted by the Course Farrier.

After being loaded into the starting stalls, WILLIE JOHN threw its head down, forced the front gates open and was restrained by a handler. WILLIE JOHN was withdrawn upon advice of the Regulatory Veterinarian. All monies invested on WILLIE JOHN were ordered to be refunded. A deduction of 35 cents per rupee was applied. The Stipendiary Stewards suspended the gelding for the rest of 2025 Racing Season.

GRAND VISION was fractious in the starting stalls and reared up on two occasions, kicked the back gate and got its off hind leg caught in the back gate. It was unloaded examined by the Regulatory Veterinarian and upon the recommendation of the Regulatory Veterinarian, the Stipendiary Stewards ordered the withdrawal of this horse. All monies invested on GRAND VISION were ordered to be refunded. A deduction of 7 cents per rupee was applied. In view of this, the Stipendiary Stewards suspended the horse for seven days and advised Trainer Allet that GRAND VISION will be required to pass a barrier trial to the satisfaction of the Stipendiary Stewards prior to being eligible to race again.

ABSOLUTIST was very slow to begin, losing considerable ground.

BUGALUGS and BACKPACKER were slow to begin.

TRANSONIC raced wide in the early and middle stages.

Near the 450m, BUGALUGS became awkwardly placed close to the heels of MANHATTEN CAFE and shifted out momentarily when eased to avoid its heels. BACKPACKER which was following, was inconvenienced and had to be taken out to avoid the heels of BUGALUGS.

Leaving the 300m, MANHATTEN CAFE was switched to the outside of MENELAUS to improve its position and in doing so, carried WILLIAMTHEFIGHTER wider on the track.

Passing the 250m, BUGALUGS was switched to the inside of MENELAUS to secure clear running.

Jockey Rama signed and Admission of Guilt for a contravention of Rule 29.2.3 in that whilst riding the horse ABSOLUTIST, he used his whip in an improper manner when this horse had no reasonable prospect of improving its position and was out of contention for a place. He was fined MUR 4,000.

At an inquiry opened in the handling of horse TRANSONIC, Trainer Mahadia explained that he had two runners in the race, namely MANHATTEN CAFE and TRANSONIC, both having front-running form. After considering evidence presented by trainer Mahadia, it was established that he had instructed both jockeys to contest for the lead, with the faster horse expected to lead while the other, if unable to do so, would settle in a handy position. In the event that the pace slowed, the latter was to improve on the outside to attempt to regain the lead.

Jockey Perez explained that after jumping reasonably well, TRANSONIC was somewhat sluggish in the early stages, which required him to urge his mount forward to keep MENELAUS and WILLIAMTHEFIGHTER out. However, both horses showed superior early speed and eventually crossed in front of him. He then elected to settle behind the pace, one off the rails, before angling his mount out near the 1000-metre mark to improve on the outside, in an attempt to secure the lead. He added that as he improved around WILLIAMTHEFIGHTER Jockey Santana asked his mount for an effort, resulting in TRANSONIC being caught three-wide from that point and subsequently fading from the 400 metres.

Trainer Mahadia further stated that TRANSONIC is a difficult horse that requires conditions to suit, in order for it to perform at his best, and tends to run well only when able to secure an uncontested lead and dictate the pace. The Stewards were presented video footage of the horses' past runs, which were viewed in the presence of the trainer Mahadia and jockey Perez.

After consideration, the Stewards decided to take no further action in the matter.

RACE 6: THE SP SEEDLING SUBSTRATE CHALLENGE CUP 1365M – [BM 61]

Passing the 1300m, CAPTAIN MIKE had to be eased when crowded for room on the inside of DARING DASH.

On inquiry, Jockey Perez pleaded guilty to a contravention of Rule 43.2.5 for having carelessly allowed his mount to shift in when insufficiently clear of CAPTAIN MIKE resulting in that gelding having to be checked. He was suspended to ride in races for one Mauritian race meeting.

DARING DASH raced fiercely in the early and middle stages.

THOMAS HENRY was not persevered with in the final stages of the home straight.

RACE 7: THE SOIL PLUS LTD CHALLENGE CUP 1400M – [65+]

PORT LOUIS hesitated at the start and was slow to begin losing considerable ground.

GOETHE stood awkwardly, threw its head on jumping and was slow to begin.

XAVION rushed the front gate of the starting stall.

YOUR PACE OR MINE threw its head on jumping.

GOETHE raced wide throughout.

Passing the 1200m, XAVION commenced to race fiercely and when restrained shifted ground outwards carrying YOUR PACE OR MINE onto GOETHE.

YOUR PACE OR MINE raced fiercely in the middle stages and when restrained threw its head.

Passing the 850m, YOUR PACE OR MINE shifted ground abruptly crowding XAVION which was racing on its inside, momentarily.

GOETHE raced wide throughout.

Leaving the 400m, PORT LOUIS was switched to the outside of XAVION to secure a clear running.

Approaching the 200m, XAVION was switched to the inside of BETATHANTHEREST to secure clear running and when being taken inwards XAVION shifted in abruptly coming very close to the running rails.

RACE 8: THE SP LAWN TOP DRESSING CHALLENGE CUP 1600M – [BM 66]

ZAKHO and FREE TO WIN were slow to begin.

Leaving the 1200m, FREE TO WIN had to ease when awkwardly placed close to the heels of FAVOUR.

From passing the 700m, FREE TO WIN was switched to the outside of runners and raced wide from then onwards.

Approaching the 450m, TYRION LANNISTER was switched to the outside of MAGNUM P I to improve its position and in doing so, carried FREE TO WIN and JOIN THE DOTS wider on the track.

In the early stages of the home straight, MAGNUM P I commenced to shift ground outwards and TYRION LANNISTER commenced to shift ground inwards, with the two horses coming together passing the 150m.

From 150m, when being ridden with the whip on the right, MAGNUM P I commenced to shift ground outwards resulting in TYRION LANNISTER, which was racing on its outside, shying away from it and being carried outwards slightly on the track.

After the running of this race, the Stipendiary Stewards sounded the inquiry signal and considered an objection lodged by Trainer Allet, trainer of the horse TYRION LANNISTER which finished 2nd, against the winner MAGNUM P I on the grounds of interference in the home straight. Evidence was taken from Jockeys Schwarz and Santana and Trainers Allet and Ruhee, respectively. It was established that from leaving the 150m, when being ridden with a whip in the right hand, MAGNUM P I shifted away from the whip resulting in TYRION LANNISTER which was racing on its outside, shying away from MAGNUM P I and shifting ground outwards. The Stipendiary Stewards, taking into consideration the degree of interference and the margin of 0.10L and the fact that Jockey Schwarz never stopped riding his horse, dismissed the objection and the Judge's result on the semaphored numbers was confirmed.

NEW YORK CITY was slow into stride.

MYSTIC MAJESTY half reared and shifted ground inwards crowding MIND MAP onto PAVED WITH GOLD.

NEW YORK CITY raced wide entering the home straight and commenced to hang inwards.

- Routine post-race urine and blood specimens were taken for analysis from all winners (Race 2 – CYBOTIX and Race 8 – MAGNUM P I: only blood specimens were taken) and from PORT LOUIS (Race 7), GANG LEADER (Race 9).
- All Jockeys passed a breathalyser test and urine specimens were taken from Jockeys Rama, Taka and Horil for analysis.
