**GENERAL**

2. A Communique in respect of Horse **Transonic** was issued at 13h30.

**RACE 1: THE ACUPPA – RED STAR TROPHY – 1600M – [0-26]**

The start of this race was delayed due to **Dance To The Sun** casting its off hind shoe, which had to be attended to, prior to leaving the paddock.

**Lomu** – Bumped at the start. Approaching the 1500, was carried inwards onto **Spirito Selvaggio**, with **Spirito Selvaggio** being cramped for room and having to be eased. Commenced to race fiercely approaching the 1300m and when being settled, got its head up and raced ungenerously for some distance. Was hanging out throughout. Approaching the 450m, commenced to shift ground outwards badly and proved difficult to control. Over the concluding 100m, hung out away from the whip.

**New World** – Leaving the 1450m, when being settled, got its head up and raced ungenerously for some distance.

**Dance To The Sun** – Was slow to begin and shortly thereafter, was inconvenienced when **Lunar Descent** shied away from **New World** on its outside, and shifted ground inwards. Leaving the 250m, was taken to the inside of **Lava Burst** to secure clear running.

**Spirito Selvaggio** – Was slow into stride. Approaching the 1500m, was cramped for room on the inside of **Lomu** and had to be eased when **Lomu** was carried in by **Lava Burst**, which in turn was carried in by **Lunar Descent**, which in turn was carried inwards by **New World**.

**Love On Time** – Fly-jumped at the start, resulting in apprentice Kulloo becoming unbalanced, with **Love On Time** shifting ground outwards, bumping **Lomu** and being very slow to begin.

**Lava Burst** – Jumped inwards, inconveniencing **Sockeroo**. Approaching the 1500m, was carried inwards onto **Lomu** by **Lunar Descent**, which was being carried inwards by **New World**. In this incident, **Lava Burst** bumped **Lomu** onto **Spirito Selvaggio**, which was running on its inside, resulting in **Spirito Selvaggio** being cramped for room and having to be eased. Approaching the 250m, for some distance, was held up when unable to improve from behind **Spirito Selvaggio**. Leaving the 250m, was switched to the inside of **Spirito Selvaggio** to secure clear running.

**Lunar Descent** – Shortly after the start, shied away from **New World**, which was racing on its outside, and shifted ground inwards, inconveniencing **Dance To The Sun**. Approaching the 1500m, was carried inwards by **New World**, which was being taken in when insufficiently clear and had to be checked, losing its position. At an inquiry into this incident, Jockey Sooful (**New World**) pleaded guilty to a contravention of Rule 414 (g) in that he carelessly allowed his mount to shift inwards when insufficiently clear of **Lunar Descent**, which was forced to check. He was suspended from riding in races for one Mauritian race meeting.

**Sockeroo** – Was slow into stride and was inconvenienced shortly thereafter. Leaving the 1100m, commenced to lose ground to the rest of the field, despite apprentice Appou's urgings. A subsequent veterinary endoscopic examination of this gelding revealed a grade 4 complete paralysis (hemiplegia) of the larynx. Accordingly, Trainer Sewdyl was informed that **Sockeroo** has been suspended indefinitely.

**RACE 2: THE BOUNGI & POPS FUN DAY TROPHY – 990M – [B.31]**

**Unsung Hero** – Jumped outwards, contacting **Bombardier Boy**.

**Cliff Swallow** – Leaving the 200m, Jockey Mansour’s whip became entangled in its rein. When questioned, Jockey Mansour explained that entering the home straight, his whip was in his right hand and when attempting to switch it from his right hand to his left hand, his rein looped around the whip handle with it becoming entangled in its reins and forcing him to have to pull it through with some force to be able to free it. He added that during this incident, he momentarily lost the use of his left side rein for a number of strides. He concluded that he managed to free his whip from its rein, passing the 100m. After reviewing the video footage, the Stipendiary Stewards decided not to proceed any further in this line of questioning.

**Fine One** – Was slow into stride. Leaving the 700m, commenced to race fiercely and approaching the 600m, was carried outwards onto **Mystery Cache**. Raced wide from approaching the 300m. Passing the 150m, was switched to the outside of **Mystery Cache** to continue going forward.

**Bombardier Boy** – Jumped awkwardly and shifted ground inwards, bumping **Unsung Hero**, which had jumped outwards. It was then slow into stride. Leaving the 700m, commenced to race fiercely and approaching the 600m, became awkwardly placed close to the heels of **Carnarvon** and when being eased, shifted ground outwards, carrying **Fine One** outwards onto **Mystery Cache**. Passing the 300m, was taken to the outside of **Carnarvon** to improve its position. At the same time, **Carnarvon** commenced to improve on its inside, resulting in **Bombardier Boy** being taken back to the inside of **Carnarvon** to secure clear running. Over the concluding 50m, was baulked for a clear run between **Unsung Hero** and **Holds The Key**, and could not be tested out to the finish.

**Carnarvon** – Leaving the 800m, was inconvenienced and had to be steadied when **Holds The Key** was taken inwards. **Bombardier Boy**, which was following, was also inconvenienced and had to be steadied.

**Holds The Key** – Leaving the 800m, was taken inwards, resulting in **Carnarvon** becoming inconvenienced and having to be steadied. **Bombardier Boy**, which was following, was also inconvenienced and had to be steadied. Jockey Sooful was shown the video footage of this incident, issued with a warning and advised to ensure that he is clear of horses when shifting ground in future.

**RACE 3: THE AQUA SPRINGS REFRESHMENT TROPHY – 1600M – [B.36]**

After considering a request from Trainer Sewdyal, the Stipendiary Stewards agreed that **Captain Marsala** is to race equipped with alumite shoes. Accordingly, **Captain Marsala** raced equipped with alumite shoes. Stable Supervisor I.Chowreemootoo signed an admission of guilt for a contravention of Rule 218, in that he failed to declare alumite shoes at the time of declarations whilst acting on Trainer Sewdyal’s behalf, and was fined the sum of Rs 7,500.

**All About Love** – Over the concluding stages, was switched to the outside of **My Archangel** to continue going forward.

**Master Of Mystery** – Jumped awkwardly with Jockey Rama becoming unbalanced on jumping. Approaching the 400m, was switched to the outside of runners to improve its position and raced wide into the home straight. Was hanging inwards in the home straight.

**Captain Marsala** – Jumped awkwardly and was slow to begin. Was inconvenienced shortly thereafter.

**Amancio** – Was slow to begin and shortly thereafter, was crowded onto **Master Of Mystery** by **Brand New World**, which had jumped outwards. Approaching the 1200m, was shifted to the outside of **Brand New World** and in doing so, carried **Backpacker** wider on the track, with

**Backpacker** racing wide from then onwards. When questioned regarding its apparent poor performance, Jockey Danielson explained that this gelding had jumped only fairly, as such, he elected to settle it at the back of the field. He added that from then onwards, it raced relaxed but when asked for an effort leaving the 400m, **Amancio** failed to quicken and was disappointing.

**Canford Club** – When being ridden with the whip in the left hand, shifted ground inwards, with Jockey Taka putting his whip away leaving the 100m and straightening his mount, Jockey Taka was shown video footage of the home straight, issued with a warning, and told that in future, he is to stop riding with the whip and straighten his mounts earlier than he did on this occasion.

**Royal Port Louis** – Jumped awkwardly and shifted ground inwards, inconveniencing **Captain Marsala**.

**Backpacker** – Carried wide by **Amancio** approaching the 1200m and raced wide until entering the back straight.

**Brand New World** – Jumped outwards, crowding **Amancio** onto **Master Of Mystery**. Approaching the 500m, was switched to the outside of runners and raced wide from then onwards.

**General:**

Jockey Rama (**Master Of Mystery**) signed an admission of guilt for a contravention of Rule 414 (I), in that he made an excessive celebratory gesture prior to the horse passing the winning post. Jockey Rama was fined Rs 5,000.

**RACE 4: THE BOUNGI & POPS FAMILY TROPHY – 1400M – [B.46]**

Acting on veterinary advice that **Opague** was lame near hind, the Stipendiary Stewards ordered its withdrawal at 08h26 on Friday 12<sup>th</sup> June. In view of this, all bets placed on **Opague** were ordered to be refunded, and a deduction of 12 cents per rupee on winning bets prior to the withdrawal of **Opague** were applied.

**Babylon** – Jumped awkwardly and shifted ground outwards. Leaving the 1300m, raced wide.

**Salt 'N Peppa** – Raced fiercely in the middle stages. Passing the 400m, for some distance, was held up when unable to improve from behind **Sea Dance**. Leaving the 250m, was switched to the outside of **Sea Dance** to secure clear running.

**Comedy Club** – Jumped awkwardly and was slow into stride. Approaching the 1200m, ran out of galloping room on the inside of **Salt 'N Peppa** and had to be steadied. At an inquiry into this incident, Jockey Nunes (**Salt 'N Peppa**) was issued a severe warning under Rule 414 (g) for allowing his mount to shift ground inwards when not sufficiently clear of **Comedy Club**. Passing the 1200m, had to be steadied when awkwardly placed close to the heels of **Salt 'N Peppa**, which in turn when held tight by **Babylon**. Jockey Perez (**Babylon**) was shown video footage of this incident, issued with a warning and told that he is to allow enough room to horses on his inside at all times. Approaching the 300m, was switched to the outside of runners to improve its position and raced wide into the home straight. Leaving the 200m, was hanging inwards.

#### **RACE 5: THE BOUNGI & POPS CELEBRATION TROPHY – 1365M – [B.56]**

**Captain Mike** – Knuckled on jumping. Came off the crossing at the 1000m awkwardly.

**Spirit's Unite** – Jumped awkwardly and shifted ground outwards, making contact with **Moonlight Trader**, which had jumped inwards. Came off the crossing at the 1000m awkwardly and stumbled. Leaving the 900m, commenced to race fiercely. Leaving the 700m, was allowed to stride forward to secure the lead.

**Moonlight Trader** – Leaving the 1000m, commenced to race fiercely and when being settled, got its head up and raced ungenerously for some distance. Passing the 900m, when still racing fiercely, had difficulty cornering and shifted out, carrying **Spirit's Unite** wide. Passing the 200m, improved into a tight gap between **Captain Mike** and **United Prince**.

**United Prince** – Half-reared and was slow to begin. Leaving the 250m, was switched to the inside of **Captain Mike** to secure clear running.

**Van Hunks** – Shortly after the start, shifted ground outwards, brushing **We Have Touchdown**. Approaching the 300m, was switched to the outside of **Spirit's Unite** to improve its position and

in doing so, carried **We Have Touchdown** wider on the track. In the early stages of the home straight, raced tight onto **We Have Touchdown**, which shifted ground inwards despite Jockey Van Niekerk's attempt to straighten it. Approaching the 100m, when being ridden with the whip in the left hand, shifted ground inwards, resulting in it becoming inconvenienced and having to be eased.

**We Have Touchdown** – Brushed on jumping. Approaching the 1200m, became awkwardly placed close to the heels of **Van Hunks**, which was being settled, and had to be steadied. Raced wide from leaving the 500m. In the early stages of the home straight, shifted ground inwards despite Jockey Van Niekerk's attempt to straighten it and raced tight onto **Van Hunks**. Shifted ground inwards over the concluding 150 metres with **Van Hunks** (L.Corrales) becoming cramped for galloping room in its inside passing the 50 metres, and having to be eased. On inquiry, Jockey Van Niekerk pleaded guilty to a breach of rule 414 (g) for careless riding. He was suspended to ride in races for one Mauritian race meeting and fined Rs 30,000.

**RACE 6: THE AQUA SPRINGS – MAURITIUS GUINEAS CUP – GROUP 2 – 1600M**

**Cumbre Vieja** – Raced fiercely in the middle stages. Approaching the 300m, improved on the inside of **Brave Bomber**, which had shifted ground outwards. Leaving the 200m, when being ridden with the whip in the right hand, commenced to shift ground outwards, with Jockey Nunes switching his whip to his left hand.

**Havana Moon** – Hesitated at the start and shifted ground outwards.

**Brave Bomber** – Leaving the 400m, commenced to shift ground outwards with **Cumbre Vieja** improving on its inside. When questioned, Jockey Juglall explained that leaving the 450m, when asked for an effort to improve, **Brave Bomber** commenced to shift ground outwards with him turning its head to the inside in an attempt to straighten it but as he did so, **Brave Bomber**

changed legs and shifted out even further despite his continuous attempts to bring it back onto the rails.

#### **RACE 7: THE AQUA SPRINGS ELITE STAKES – 1365M – PINNACLE STAKES**

After considering a request from Trainer Mahadia, the Stipendiary Stewards agreed that **Captain Bombshell** is to race equipped with alumite shoes. Accordingly, **Captain Bombshell** raced equipped with alumite shoes. Trainer Mahadia signed an admission of guilt for a contravention of Rule 218, in that he failed to declare alumite shoes at the time of declarations, and was fined the sum of Rs 7,500.

**Sun Blushed** – Raced wide in the early and middle stages. Leaving the 1300m, when racing on the outside of **Formagear**, was carried outwards onto **Boundless Energy**, which was being angled inwards to secure a position closer to the rails. In this incident, **Sun Blushed** clipped the heels of **Boundless Energy** and stumbled. On inquiry, it was established that leaving the 1300m, **The Grey King** (G.van Niekerk) commenced to race fiercely and when being restrained, jockey Van Niekerk’s right rein slipped, with him losing a hold of his rein for a number of strides, resulting in the gelding shifting ground outwards sharply and carrying **Formagear** (C.Collis) outwards onto **Sun Blushed** (R.Danielson). At the same time, **Boundless Energy** (M.Nunes) was being taken inwards to secure a position closer to the running rails, with **Sun Blushed** being carried outwards onto the heels of **Boundless Energy**, clipping its heels and stumbling. The Stewards being of the opinion that this incident could not be attributed to any one particular rider, decided not to proceed any further other than to record it as a racing incident. Was hanging inwards in the home straight.

**Captain Bombshell** – Was slow to begin. Leaving the 1300m, when racing fiercely and had its head up, clipped the heels of **Formagear** and stumbled, with Jockey Joorawon becoming unbalanced and falling back in the saddle. Following this incident, **Captain Bombshell** raced ungenerously with its head up for some distance. Leaving the 600m, was switched to the outside of **Sun Blushed** to improve its position and in doing so, raced tight onto **Rapidash** and carried

**Rapidash** wider on the track. Leaving the 450m, when racing tight on the inside of **Rapidash**, had to be eased to avoid the heels of **Rapidash**.

**Unzen** – Taken inwards passing the 1300m, which resulted in **Formagear** becoming awkwardly placed close to its heels. On inquiry, Apprentice Kulloo was issued with a warning and advised that in future he must ensure that he is clear of horses before shifting ground.

**Bless My Path** – Hesitated at the start and was slow to begin.

**Formagear** – Passing the 1300m, had to be eased when awkwardly placed close to the heels of **Unzen**, which was being taken inwards. Shortly thereafter, was carried outwards by **The Grey King**, resulting in **Sun Blushed**, which was racing on the outside of **Formagear**, being carried outwards onto **Boundless Energy**, which was being angled inwards to secure a position closer to the rails. In this incident, **Sun Blushed** clipped the heels of **Boundless Energy** and stumbled. Was hanging inwards in the home straight.

**Rapidash** – Was slow into stride. From leaving the 600m, raced tight onto **Captain Bombshell** and leaving the 450m, shifted ground inwards, crowding **Captain Bombshell**, resulting in the latter having to be eased. On inquiry, Jockey Mansour was charged for a breach of Rule 414 (g). After hearing evidence adduced by Jockey Mansour in his defence, the Stewards concluded that the explanations of Jockey Mansour were plausible and accepted that jockey Joorawon has contributed to the incident upon leaving the 600m. In the circumstances, the Stewards did not find jockey Mansour guilty of the charge. Passing the 200m, was switched to the inside of horses to continue going forward. Carried inwards over the concluding stages.

**Boundless Energy** – Was hanging inwards over the concluding stages.

**The Grey King** – Raced fiercely in the middle stages and approaching the 1000m, became awkwardly placed close to the heels of **Unzen**.

**RACE 8: THE SPECIAL IDOL PLATE – 1650M – MIDDLE STAKES**

**Magnum P I** – Leaving the 1300m, commenced to race fiercely. Raced fiercely in the early and middle stages and approaching the 1000m, was awkwardly placed close to the heels of **Palermo**. Leaving the 900m, was switched to the outside of **Palermo** momentarily, and was pushed back towards the rails by Jockey Collis (**Secret Oasis**), which was racing on its outside. On inquiry, Jockey Collis (**Secret Oasis**) was found guilty of a breach of Rule 414 (d) for riding in an improper manner, in that passing the 850m, when racing on the outside of **Magnum P I** (S.Rama), as Jockey Rama was attempting to move away from behind **Palermo** (T.Juglall) to avoid its heels, he angled his mount inwards for a number of strides towards **Magnum P I** with his right elbow raised, pushing jockey Rama inwards in an aggressive manner thereby creating an unsafe situation at that stage of the race. He was suspended from riding in races for three Mauritian race meetings.

**Bacchus** – Was slow to begin. Slightly inconvenienced shortly thereafter. Passing the 450m, was switched to the outside of runners to improve its position and raced wide into the home straight.

**Prime Example** – Was slow to begin.

**Zakho** – Shortly after the start, shifted ground inwards, slightly inconveniencing **Bacchus** and had to be straightened, and was slow into stride. Leaving the 450m, was switched to the outside of runners to improve its position and raced wide from then onwards.

**Secret Oasis** – Was hanging inwards in the home straight.

**Superior Force** – Leaving the 300m, was switched to the outside of runners to improve its position and made the turn into the home straight very wide.

**Roman’s Revenge** – Raced fiercely in the early stages.

**Palermo** – Reared as the start was effected. Leaving the 1300m, shifted ground outwards. Commenced to give ground from leaving the 300m and was not persevered with over the concluding stages. Jockey Juglall reported that this gelding raced fiercely in the early and middle stages.
