Race 8: **DANILO DANILOVITCH** (Trainer Mootien and Apprentice Kulloo)

Prior to the race meeting, Jockeys Curatolo and Mansour submitted their medical reports to the Stipendiary Stewards, and were cleared to ride.

RACE 1: LE TURBO – RED STAR TROPHY – 1500M – [0-25]

Following the running of this race, the Stipendiary Stewards sounded the inquiry siren and reviewed video replays of the start. It was established that prior to the start being effected, **Fire Starter** rushed the front gate of its stall. After reviewing the footage of the start, the Stipendiary Stewards were satisfied that there was no advantage gained at the start and took no further action, with the correct weight being declared on the Judges' Semaphored numbers.

Zooberi – Raced wide in the early stages. Leaving the 900m, was urged forward to secure a position closer to the rails. Leaving the 500m, when being urged forward, commenced to hang out, despite Apprentice Sophie's attempts to straighten it. Commenced to give ground from leaving the 300m.

Fire Starter – Shortly after the start, was crowded onto **Kola Tonic**, which resulted in **Kola Tonic** losing its position. Leaving the 150m, when being ridden with the whip in the left hand, commenced to shift ground inwards and brushed **River Hawk**, which was racing on its inside. Jockey Ramsamy was shown video footage of this section of the race, issued with a warning and advised to stop riding with the whip and straighten his mounts earlier than he did on this occasion when they shift ground in future.

Kola Tonic – Slow into stride and shortly thereafter, was crowded for room on the inside of **Fire Starter** and lost its position. Passing the 1200m, when attempting to secure a position next to **River Hawk**, got its head up and raced ungenerously for some distance. Approaching the 450m, was switched to the outside of **Cosmic Captain** and raced wide from then onwards.

Gang Leader – Shortly after jumping, shifted ground inwards, resulting in **Zooberi** shying away and shifting ground inwards onto **Fire Starter**.

River Hawk – Passing the 250m, was switched to the inside of **Fire Starter** to secure clear running. Passing the 100m, commenced to shift ground outwards and carried **Fire Starter** outwards. Jockey Sooful was shown video footage of this section of the race, issued with a warning and

advised to stop riding with the whip earlier than he did on this occasion and straighten his mounts when they shift ground in future. When questioned with regards to its apparent improved performance, Trainer Gujadhur explained that **River Hawk** had improved before its last start, however it proved to be extremely disappointing. For today's race, the gelding had pleased in the lead-up, showing improvement at track work with Jockey Sooful in the saddle. As such an improved run was expected, although he did not expect it to win. In his opinion, the even pace in the race may have contributed to its improved performance.

Cosmic Captain – Leaving the 1300m, was slightly inconvenienced and had to be steadied when awkwardly placed close to the heels of **Fire Starter**.

Cloud Seeder – Over the concluding stages, was switched to the outside of **Gang Leader** and **Cosmic Captain** to continue going forward. Jockey Sonaram reported that this gelding took no interest in the early stages of the race and was not travelling well.

Lingotto – Slow into stride. Raced fiercely in the early stages and leaving the 1300m, was eased when awkwardly placed close to the heels of **River Hawk**.

RACE 2: THE CAVENDISH MEMORIAL CUP – 1650M – [B.31]

Exalted Love – Leaving the 300m, was switched to the outside of **Royal Port Louis** to improve its position.

San Andreas – Approaching the 700m, was switched to the outside of runners to improve its position and raced wide leaving the 600m.

Amancio – Slow to begin.

Taking Silk – Leaving the 450m, despite being urged forward, commenced to give ground from the rest of the field, fading in the home straight.

RACE 3: THE VEEJAY KUMAR BEEHAREE MEMORIAL CUP – 1365M – [0-26]

Fine One – Jumped awkwardly, shifted ground inwards, and brushed **Blown Away** on its hindquarters. Leaving the 1100m for some distance, raced in restricted room on the inside of **Fear Of Fire** and passing the 1000m, had to be restrained when awkwardly placed close to the heels of **Blown Away**. Was hanging outwards in the home straight. When questioned, Jockey Orffer explained that this gelding had pleased in the lead-up to this race and he was expecting a forward showing. He added that he had to ask his mount for an effort leaving the 1200m to keep the position behind the leader, as **Fear Of Fire** showed intention to secure that position. He further added that from then onwards, **Fine One** commenced to race fiercely and when asked for an effort leaving the 400m, failed to quicken, being extremely disappointing. A subsequent veterinary examination of **Fine One** revealed it was coughing.

Lava County – Stood flat-footed and lost considerable ground at the start. Carried wide leaving the 450m and raced wide into the home straight. Was hanging inwards in the home straight.

Master Point – Raced wide in the early stages and passing the 1200m, was eased to secure a position closer to the rails. Leaving the 450m, was switched to the outside of **Fine One** and in doing so, carried **Lava County** wider on the track. Passing the 250m, was switched to the outside of **Fear Of Fire** to continue going forward and raced wide into the home straight.

Fear Of Fire – Passing the 1200m, when eased to settle off the leader, commenced to race fiercely and from leaving the 1100m, raced tight onto **Fine One**.

Midnight Flyer – Leaving the 250m, was switched to the inside of runners to secure clear running.

Blown Away – Brushed on its hindquarters at the start. Came off the crossing at the 450m awkwardly and dipped.

RACE 4: THE ROTARY END POLIO CUP – 1450M – [B.51]

United Prince – Leaving the 800m, was urged forward to keep its position behind **Captain Cola**. Leaving the 250m, was switched to the inside of runners to continue going forward. On inquiry, Trainer Ruhee explained that this gelding races better when on the fence. As such after going through the card, he was of the opinion that the horses with pace were drawn wide, except for **Makazole** who he thought could contest the lead and was drawn on the inside of **United Prince**. He added that **United Prince** had led over 1400 m against weaker opposition and was trying the 1450 m for the first time in its career. As such, he instructed Jockey Schwarz to get **United Prince** to jump well and if able to get to the lead uncontested to do so, otherwise to try to position that gelding on the rails behind the leaders if possible. Jockey Schwarz confirmed these instructions and explained that **United Prince** jumped very well, but that **Makazole** was going as well on its inside. Being wary of the fact that **United Price** can pull in in its races, he decided against insisting to try to clear **Makazole**. He added that leaving the 1300m, he saw that a run gap created itself behind **Makazole** and tried to ease back **United Prince** to secure that gap but was unable to do so, as **United Prince** was racing keen and he would have had to break its stride to be able to secure the run on the rails behind **Makazole**. After consideration, the Stewards decided not to proceed further other than to tell Jockey Schwarz that his ride had come under notice and that he is to make more of an effort in future to ride as per instructions received.

Captain Cola – Leaving the 250m, was inconvenienced and had to be taken out to continue going forward.

Makazole – Leaving the 250m, shifted ground outwards, which resulted in **Captain Cola**, which was racing on its outside, becoming inconvenienced and having to be taken out to continue going forward. Was hanging outwards in the home straight.

Manhattan Cafe – Raced wide throughout and commenced to give ground from leaving the 450m, finishing tailed off.

Opague – Leaving the 900m, was switched to the outside of runners to improve its position and raced wide from then onwards.

Comedy Club – Slow into stride. Leaving the 200m, was switched to the inside of **Rich Folks Hoax** to continue going forward.

RACE 5: THE ROTARY CLUB LE RÉDUIT CUP – MIDDLE STAKES – 990M

Following the running of this race, the Stipendiary Stewards sounded the inquiry siren, viewed the video replays of the home straight and considered an objection lodged by Jockey Curatolo, rider of second placed **Captain Mike**, against the winner, **Warhead** on the grounds of interference in the closing stages. Evidence was taken from Jockeys Curatolo, Schwarz and Trainers Allet and Ruhee. After considering the evidence, viewing the video footage of the closing stages from all angles, taking consideration the degree of interference and the winning margin of 0.75L at the finish, the Stipendiary Stewards were satisfied that **Captain Mike** would not have finished ahead of **Warhead**. Jockey Curatolo's objection was therefore over-ruled in terms of Rule 449 (a) and the correct weight was declared on the Judges' Semaphored Numbers. Jockey Schwarz was shown video replays of the closing stages, issued with a severe warning and advised that in future, he is to stop riding with the whip and straighten his mounts when they shift ground.

Solomons Seal – Approaching the 400m, was switched to the outside of runners and raced wide into the home straight.

Warhead – Slow to begin. Passing the 150m, shifted ground outwards, slightly inconveniencing **Captain Mike**.

Jewel Cat – Shifted ground outwards passing the 900m. Was hanging inwards throughout and brushed the running rails passing the 600m.

Captain Mike – Slightly inconvenienced passing the 150m.

Mystery Cache – Slow to begin and passing the 900m, was steadied when racing in restricted room between **Jewel Cat**, which had shifted ground outwards, and **Captain Mike**. Leaving the 800m, commenced to race fiercely and when being restrained to avoid the heels of **Jewel Cat**, got its head up and raced ungenerously for some distance

RACE 6: THE AQUA SPRINGS MAURITIUS DERBY – GROUP 1 – 1850M
Bounceback – Jumped awkwardly and was slow into stride.

Unsung Hero – Fractious in its stall prior to the start being effected. Fly-jumped. Shortly after the start, commenced to race fiercely and when being settled, threw its head up and raced ungenerously over a short distance. Leaving the 1700m, clipped the heels of **New York City** and stumbled. On inquiry, Jockey Ramsamy was found guilty of a breach of Rule 414 (b) in that being the rider of **Unsung Hero**, he failed to ride that gelding to the satisfaction of the Stewards, the particulars being that after having failed to settle **Unsung Hero** in the early stages of the race due to it pulling hard, from approaching the 1500m, when there was an opportunity for him to put his hands down and let that gelding race in its pace, he instead over restrained the latter, resulting in **Unsung Hero** fighting with its head until leaving the 1300m, this being counterproductive to its chances in the race. He was suspended to ride in races for three race meetings.

New York City – On inquiry, Jockey Bhaugerothee was found guilty of a breach of Rule 414 (b) for failing to ride that gelding to the satisfaction of the Stewards, the particulars being that after jumping well and being able to secure a position on the outside of the leader, **Cumbre Vieja**, leaving the crossing at 'La Rue du Gouvernement', when **Cumbre Vieja** slowed down the pace, instead of allowing his mount to race in its pace, he unnecessarily restrained **New York City** resulting in that horse throwing its head and racing ungenerously until passing the 1300 m, which was counter-productive to its chances in the race. He was suspended to ride in races for three race meetings.

RACE 7: THE ROTARY FOUNDATION CUP – PINNACLE STAKES – 1650M

Meridius – Leaving the 1500m, lost interest in the race and gave ground to the rest of the field. Leaving the 900m, bridged the gap to the rest of the field. Leaving the 600m, again lost interest in the race and gave ground to the rest of the field. When questioned, Jockey Orffer explained that after jumping, he felt his mount drop the bit and shortened its stride, and when he endeavoured to encourage his mount, **Meridius** further shortened its stride, losing ground. He added that he then decided to sit still on the gelding and allow it to race in its pace. He further added that **Meridius** then slowly made up ground to rejoin the field passing the 1000m. Jockey Orffer further explained that down the backstraight, **Meridius** then felt comfortable and kept pace with the field. He further stated that when asked for an effort leaving the 600m, **Meridius** failed to respond and pinned its ears and eased up, with him losing ground yet again, but upon straightening for home, it again picked up the bit and quickened to make up ground in the closing stages. Jockey Orffer further added that at track work, **Meridius** had also demonstrated erratic behaviour and recommended a change of equipment to Trainer Narang to address this issue. In view of this gelding's performance, it has been suspended for 30 days and will be required to pass a Barrier Trial to the satisfaction of the Stipendiary Stewards appropriately equipped to improve this behaviour.

Xavion – Carried wide approaching the 600m and raced wide from then onwards.

Zil Moris – Passing the 300m, was switched to the outside of **The Mauritian** and approaching the 250m, to the outside of **Havana Moon** to continue going forward and in doing so, carried **Xavion** wide. Was hanging inwards in the home straight.

Havana Moon – Approaching the 600m, was switched to the outside of **The Mauritian** and in doing so, carried **Xavion** wider on the track, with **Xavion** racing wide from then onwards.

RACE 8: THE RACING ORAX CUP – 1365M – [B.41]

Following the running of this race, the Stipendiary Stewards sounded the inquiry siren and viewed video footage of the closing stages. It was established that approaching the 75m mark, **Ibhele**, which was shifting ground inwards, and **Theres A Light**, which was shifting ground outwards, came together and raced tight over the concluding stages, with both Jockeys riding their mounts out to the finish. The Stipendiary Stewards, being of the opinion that this incident had no bearing on the finishing positions of both horses, decided not to proceed further and the correct weight was declared on the Judges' Semaphored numbers. Jockeys Curatolo and Orffer appeared before the Stipendiary Stewards and were questioned regarding the closing stages of the race. The Stipendiary Stewards had concerns regarding Jockey Orffer's change of riding style, where Jockey Orffer raised his elbow close to Jockey Curatolo in a tight finish. Jockey Curatolo gave evidence to the effect that he did not feel impeded by Jockey Orffer at that stage of the race, and was able to ride his mount to the finish. In light of the evidence, the Stipendiary Stewards took no further action, other than to tell Jockey Orffer to exercise care towards his fellow riders in future.

Danilo Danilovitch – Slow to begin. Approaching the 1100m, was taken out from behind **World Warrior** and allowed to stride forward to race closer to the lead. In doing, carried **Sound Of The Sea** wider on the track. On inquiry, Trainer Mootien explained that he instructed Apprentice Kulloo to jump and secure a midfield position, wait for the 400m to make his move as that gelding has a short burst. He added that he had concerns with the way the Apprentice rode **Danilo Danilovitch** in the early stages of the race, further adding that leaving the 1300m, a gap had created itself between **Danilo Danilovitch** and **Paved With Gold**, and that the apprentice ought to have urged that gelding in order to bridge the gap and secondly, he was not happy with the Apprentice improving his position to go and race next to the leader down the back straight. He also intimated to the board that Apprentice Kulloo had ridden in a such a way because he was friends with the owners of **Theres A Light** on which there was considerable betting. When questioned about such serious allegation and what proof he had, Trainer Mootien offered no evidence to the Board in support of these allegations. Apprentice Kulloo confirmed these instructions and explained that after being slow out, he had urged **Danilo Danilovitch** forward in

order to get it into the race. He added that from leaving the 1300m, he saw jockey Rama (**World Warrior**) on his outside wanting to come in to secure the position behind **Paved With Gold** and called out to him. When further questioned, he explained that he decided against asking his mount for an effort at that stage as he had already urged it forward from the start and was wary of that gelding pulling with him as it had done so in the past and he had not been able to control it. He further added that Jockey Rama came in and he found himself very close to **World Warrior's** heels and had to take evasive action and take the gelding out in order to avoid **World Warrior's** heels. He continued by saying that it was his intention to secure the one-off position behind **Ibhele**, but was unable to do so as **World Warrior**, who was pulling had been taken out and improved on his inside to secure that position. Seeing that he was racing in a three-wide position without cover, he then decided to let **Danilo Danilovitch** improve around horses and secure the one-off position on the outside of **Not In Doubt** without being urged forward where it then raced in a relaxed manner and when asked for an effort leaving the 400m it stayed one-paced. After consideration, the Stipendiary Stewards, taking into consideration **Danilo Danilovitch's** idiosyncrasies and the fact that it was being ridden by an Apprentice, decided not to proceed further. Trainer Mootien was reminded by the Stipendiary Stewards that before making serious allegations towards a licensee, he must be able to put forward with tangible proof of any wrongdoing otherwise he would face the consequences of making frivolous or vexatious allegations.

Sound Of The Sea – Jumped awkwardly, throwing its head. Carried wide passing the 1100m.

Theres A Light – Over the concluding stages, raced tight onto **Ibhele**.

Nou Praat Jy – Slow to begin.

Ibhele – Over the concluding stages, raced tight onto **Theres A Light**.

Paved With Gold – Slightly inconvenienced leaving the 700m. Leaving the 250m, was switched to the inside of **Theres A Light** and **Not In Doubt** to secure clear running.

World Warrior – Leaving the 1200m, wen being settled, got its head up and raced ungenerously over a short distance. Leaving the 700m, shifted ground inwards, despite Jockey Rama's attempt to straighten it, and slightly inconvenienced **Paved With Gold**. Leaving the 450m, was switched to the outside of runners to improve its position and raced wide into the home straight.
